CHAPTER 7.

Names changed. *Be it enacted by the General Assembly of Maryland, That the names of Frederick Shaffer Littig, Catharine Ann Littig, Ann Maria Littig, Rachel Littig, Hannah Ann Littig, Frederick Shaffer Littig, junr., William Pitt Littig, Julia Bates Littig and Louisa Emily Littig, of the city of Baltimore, be, and the same are hereby changed to that of Frederick Littig Shaffer, Catharine Ann Littig Shaffer, Ann Maria Littig Shaffer, Rachel Littig Shaffer, Hannah Ann Littig Shaffer, Frederick Littig Shaffer, junr., William Pitt Littig Shaffer, Julia Bates Littig Shaffer and Louisa Emily Littig Shaffer; and it shall and may be lawful for the said Frederick Shaffer Littig, Catharine*
