WHEREAS, it is represented to this General Assembly that doubts are entertained, whether the trustees of Primary School, number seventeen, are authorised to act in conformity with the provisions of the act of the General Assembly, passed at December session eighteen hundred and thirty-three, chapter one hundred and ten; and whereas, a majority of the male taxable inhabitants of the said school district, by memorial, have prayed this General Assembly to pass a law, to confirm and make valid the acts and proceedings of the trustees aforesaid, as well as the acts and proceedings of their predecessors in office, and to authorise the said trustees and their successors in office to act in conformity with the provisions of the said act of Assembly of eighteen hundred and thirty-three, chapter one hundred and ten, called the Piney Neck Primary School law for Queen Anne's county -therefore, visating all mort, trained to smooth
