SECTION 1. Be it enacted by the General Assembly of Incorporated. Maryland, John E. H. Ligget, George H. Waesche, Isaac Dern, Eli Otto, Noah Pennington, Benjamin Poole, Martin Grimes, Nicholas Stansbury, Hiram Fogle, George Landers, James Thomas, William Carmack, Abednego Slick, Francis Carmack, Joseph Fogle, Jesse Anders, William Miller, Edward Carmack, Samuel Birely, of Frederick and Carroll counties, State of Maryland, and other officers and members of Double Pipe Creek Division Number Thirty-six, of the Sons of Temperance, and their successors be, and they are hereby declared to be a community, corporation and body politic, by the name and style and title of Double Pipe Creek Division Number Thirty-six, of the Sons of Temperance, and by that name, they and their successors shall, and may at all times hereafter, be capable in law to have, hold, receive and retain to them and their successors, property, real or personal, either or both; also devises or bequests or any description of property from any person or persons, capable in law of making the same, and the same at their pleasure, to transfer or dispose of in such manner as they may think proper; provided, that the said corporation or body politic, shall not at any one time hold or possess property, real or personal, or mixed, which shall be of the annual value of, or yield an income annually, exceeding three thousand dollars.
