SECTION 1. Be it enacted by the General Assembly of Incorporated,
Maryland, That P. S. Chappell, W. H. Chappell, William L. Richardson and William Leach, and such other persons as may become stockholders in said Union Chemical Works, their successors and assigns be, and they are hereby created and made a body politic and corporate, under the name and style of the Union Chemi- Name & style. cal Works, and by that name may sue and be sued, plead and be impleaded, answer and be answered unto, Establish byin any court of law or equity, and also ordain and estab-laws. lish such by-laws, rules and regulations as shall appear necessary for the management of the concerns of said corporation, not contrary to the laws of this State, or of the United States, and the same to change, add to, or amend in their discretion; and to have and use a common seal, and the same to change and renew at pleasure, and generally to do every other act or thing necessary to carry into effect the provisions of this act, or to promote the
