Be it enacted by the General Assembly of Deposit sums Maryland, That the managers of the Mutual Fire Insu- of money. rance Company of Cecil county, incorporated by the act to which this is a supplement, shall have full power and authority to deposit in some convenient bank or savings institution, any sum or sums of money which may accumulate in their hands by the payment of interest on premium notes or otherwise, and to receive such interest on said deposits as may be allowed by said bank or savings institution, and the same to withdraw according to such terms of deposit as may be agreed upon at the time of making thereof; provided, that no place of deposit Proviso. shall be selected, and no deposit once made, removed, except by a vote of two-thirds of the members of the board, and upon written order or resolution duly passed by the board, and subscribed by at least six of the mem-
