Corporate and may have and use a common seal, and be able and capable to sue and be sued plead and be impleaded in any court of law or equity, and may also have, use, exercise and enjoy all the power, privileges and rights proper and necessary for carrying on the opening, working, transporting to market and vending the produce of their lands, mines and manufactories, and shall have power to take, purchase and hold all such property, real, personal or mixed as they may require for the purposes aforesaid, and shall have power to make and enter into all manner of contracts in relation to the business and property aforesaid; provided, that the said corporation shall at no time hold or possess in this State more than two thousand acres of land, exclusive of the quantity which may be occupied as the bed of any road or roads which it may be found necessary to purchase or construct, and may for the purposes aforesaid have and exercise, except as restricted by this act, the right to make bye-laws, rules and regulations, and all the rights, privileges and powers necessary to the objects of this act, and to the use, control and disposition of the property acquired by them, and not repugnant to any law of this State, or of the United States.

SEC. 2.
