AN ACT to amend and continue in force, an act passed January session, eighteen hundred and fifty-two, chapter three hundred and sixteen, entitled, an act to authorise the appointment of a commissioner to take testimony to provide for the recording of copies of Wills and other papers, of which the originals were lost by the burning of the Court House in Dorchester county, and to remedy as far as practicable, the evils likely to arise from the destruction of the records of said county.

SECTION 1. Be it enacted by the General Assembly Act of 1852. of Maryland, That the act of Assembly passed at Jan-re-enacted. uary session, eighteen hundred and fifty-two, chapter three hundred and sixteen, entitled, an act to authorise the appointment of a commissioner to take testimony to provide for the recording of copies of wills and other papers, of which the originals were lost by the burning of the court house in Dorchester county, and to remedy as far as practicable, the evils likely to arise from the destruction of the records of said county, is hereby reenacted and continued in force, except the twentieth and twenty-fifth sections of said act, until the first day of April, eighteen hundred and fifty-six.

SEC. 2.
