

budget, for each classroom unit in operation in such county or city, respectively, computed on a full-time teacher basis. ~~Provided, however, that for the school year [1955-1956] 1958-1959 and continuing thereafter, the board of education of each county and the Mayor and City Council of Baltimore shall be entitled to and shall be paid each year in the manner and subject to the limitations hereinafter provided [\\$600] \$1,400.00, or such sum in excess thereof as may be provided in the budget for such classroom unit in operation in such county or city, respectively, computed on a full-time teacher basis.~~ The financial assistance herein authorized shall not be available or given to any county or to Baltimore City wherein any teacher receives a salary lower than that established by Section 102 of this Article.

(b) The State Superintendent of Schools shall certify to the Comptroller on or before the last day of July, ~~[and] September [~~, the tenth day of December,~~] and November~~, the last day of January, March and May, one-sixth of the annual sum due the county board of education of each county and the Mayor and City Council of Baltimore hereunder, and thereupon the Comptroller shall within five days of the above said dates draw his warrant on the Treasurer of the State of Maryland for the respective amounts due to the said boards of education and to the Mayor and City Council of Baltimore, and the Treasurer of the State of Maryland, upon receipt of said warrants shall immediately pay the amount due on said dates to said respective boards of education and to the city of Baltimore.

(C) PROVIDED FURTHER THAT NO COUNTY OR THE CITY OF BALTIMORE MAY DECREASE THE AMOUNT APPROPRIATED FROM LOCAL FUNDS FOR THE SCHOOL YEAR 1956-57 FOR TEACHERS' SALARIES IN EXCESS OF THE STATE MINIMUM SCHEDULE. SUCH LOCAL FUNDS AS REFERRED TO ABOVE SHALL BE USED TO PROVIDE INCREASED TEACHERS' SALARIES ABOVE THE NEW STATE MINIMUM SCHEDULE AS PROVIDED BY THIS ACT AND ACCORDING TO A LOCAL SALARY SCHEDULE TO BE ESTABLISHED BY THE COUNTY BOARDS OF EDUCATION OR THE BOARD OF SCHOOL COMMISSIONERS OF BALTIMORE CITY.

SEC. 4. AND BE IT FURTHER ENACTED, THAT FOR THE 1957-1958 FISCAL YEAR THE DISTRIBUTION OF INCREASED AID TO EDUCATION AS PROVIDED BY SECTION 209 OF ARTICLE 77 OF THE ANNOTATED CODE OF MARYLAND (1956 SUPPLEMENT), SHALL BE REDUCED IN EACH POLITICAL SUB-DIVISION IN THE SAME PROPORTION TO \$40,000 THAT DISTRIBUTION OF SUCH INCREASED STATE AID TO EACH SUB-DIVISION BEARS TO THE TOTAL AMOUNT OF SUCH INCREASED AID DISTRIBUTED.

SEC. 5. AND BE IT FURTHER ENACTED, THAT SUB-SECTIONS (C-1) AND (F-2) BE AND THEY ARE HEREBY ADDED TO SECTION 283 OF ARTICLE 81 OF SAID CODE (1951 EDITION AND 1956 SUPPLEMENT), TITLE "REVENUE AND TAXES", SUB-TITLE "INCOME TAX", TO FOLLOW RESPECTIVELY AFTER SUB-SECTIONS (C) AND (F-1) THEREOF; THAT SECTION 285 (E) OF SAID ARTICLE AND SUB-TITLE, BE AND IT IS HEREBY REPEALED AND RE-ENACTED, WITH
