(d) *In addition to all other fees and charges specified in this section or elsewhere in this Article, there is hereby imposed upon every public service company an annual filing fee in an amount equal to one-twentieth of one percentum (1/20%) of the company's annual gross receipts for the preceding year. The fee shall be payable on or before April 1 in any year, with the computation being based upon the gross receipts for the preceding calendar year. "Gross receipts" shall apply only to the revenues from such types of utility business and operations as are within the regulatory jurisdiction of the Commission. The proceeds of the filing fees shall be accounted for monthly into the general funds of the State Treasury.*

SEC. 2. *And be it further enacted, That the filing fee herein imposed shall first be due and payable on or before April 1, 1959, with the computation being based upon the gross receipts for the calendar year of 1958.*

SEC. 3. *And be it further enacted, That this Act shall take effect June 1, 1958.*

CHAPTER 62

(Senate Bill 135)

AN ACT to add new Section ~~9A~~ 8A to Article ~~66B~~ 23A of the Annotated Code of Maryland (1957 Edition), title "~~Zoning and Planning~~", sub-title "~~Zoning~~", "CORPORATIONS—MUNICIPAL", to follow immediately after Section ~~9~~ 8 thereof, AND TO BE UNDER THE NEW SUB-TITLE "FACILITIES OUTSIDE CORPORATE LIMITS", relating to the establishment or location of municipal or other facilities outside the limits of the municipality and the compliance with zoning regulations where such facilities are proposed to be established or located and relating generally to zoning in this State. RELATING GENERALLY TO THE ESTABLISHMENT OR LOCATION BY A MUNICIPAL CORPORATION, OR BALTIMORE CITY, OF PENAL INSTITUTIONS OR OTHER PLACES OF DETENTION OUTSIDE THE CORPORATE LIMITS THEREOF IN THIS STATE.

SECTION 1. *Be it enacted by the General Assembly of Maryland, That new Section ~~9A~~ 8A be and the same is hereby added to Article ~~66B~~ 23A of the Annotated Code of Maryland (1957 Edition), title "~~Zoning and Planning~~", sub-title "~~Zoning~~" "CORPORATIONS—MUNICIPAL", to follow immediately after Section ~~9~~ 8 thereof, AND TO BE UNDER THE NEW SUB-TITLE "FACILITIES OUTSIDE CORPORATE LIMITS", and to read as follows:*
