

“Birds, Game and Inland Water Fish”, sub-heading “Game and Fresh Water Fish”, and to enact a new section to be known as Section 200, to stand in the place and stead of the section so repealed, defining lines between tidal and non-tidal waters of the State.

AN ACT TO ADD SECTION 200A TO ARTICLE 66C OF THE ANNOTATED CODE OF MARYLAND (1951 EDITION), TITLE “NATURAL RESOURCES”, SUB-TITLE “BIRDS, GAME AND INLAND WATER FISH”, SUB-HEADING “GAME AND FRESH WATER FISH”, TO FOLLOW IMMEDIATELY AFTER SECTION 200 THEREOF, DEFINING THE LINE BETWEEN CERTAIN TIDAL AND NON-TIDAL WATERS IN CAROLINE COUNTY.

Section 1. *Be it enacted by the General Assembly of Maryland,* That Section 200 of Article 66C of the Annotated Code of Maryland (1951 Edition), title “Natural Resources”, sub-title “Birds, Game and Inland Water Fish”, sub-heading “Game and Fresh Water Fish”, be and it is hereby repealed and a new section to be known as Section 200 be and it is hereby enacted in lieu thereof, said section to stand in the place and stead of the section so repealed, and to read as follows:

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, THAT SECTION 200A BE AND IT IS HEREBY ADDED TO ARTICLE 66C OF THE ANNOTATED CODE OF MARYLAND (1951 EDITION), TITLE “NATURAL RESOURCES”, SUB-TITLE “BIRDS, GAME AND INLAND WATER FISH”, SUB-HEADING “GAME AND FRESH WATER FISH”, TO FOLLOW IMMEDIATELY AFTER SECTION 200 THEREOF, AND TO READ AS FOLLOWS:

200. *For the purpose of defining the lines between tidal and non-tidal waters, said lines shall be as follows:*

*Potomac River—Little Falls near District of Columbia Line.*

*Broad Creek (Henson Run) — Bridge on Old Broad Creek Rd., Highway No. 41.*

*Piscataway Creek—Bridge at Highway No. 224.*

*Matawoman Creek—Bridges 200 YARDS ABOVE BRIDGE at Highway No. 225.*

*Nanjemoy Creek—S. W. Branch, Trappe Bridge on Highway No. 6.*

*Wards Run—Bridge at Highway No. 6.*

*Avon River—Bridge at Highway No. 6.*

*Port Tobacco Creek—Bridge at Highway No. 6.*

*Wicomico River—Allen Fresh Run—Woodland Point ONE HALF MILE ABOVE ALLEN FRESH BRIDGE ON HIGHWAY NO. 234.*

*Newport Run—Bridge at Highway No. 234.*

*Budds Creek—Bridge at Highway No. 234.*

*Chaptico Run—Bridge at Highway No. 234 and Highway No. 238.*

*Mae Intosh Run—Bridge at Highway No. 5.*

*St. Mary's River*

*Park Hall Run—State Highway No. 5.*

*Great Mills Run—State Highway No. 5.*
