(d) *In Worcester County the Clerk of the Board of Supervisors of Elections provided for in this Article shall receive an annual salary of \$500.*

(E) IN SOMERSET COUNTY, THE CLERK OF THE BOARD OF SUPERVISORS OF ELECTIONS PROVIDED FOR IN THIS ARTICLE SHALL RECEIVE AN ANNUAL SALARY OF \$500.

SEC. 2. *And be it further enacted, That this Act shall take effect June 1, 1955.*

## CHAPTER 694

(House Bill 796)

AN ACT to repeal and re-enact, with amendments, Section 119-5a of the Montgomery County Code (1950 Edition), being Article 16 of the Code of Public Local Laws of Maryland, title "Montgomery County", sub-title "Chevy Chase—Section 4", reducing the amount of tax which may be levied or collected by the Citizens Committee of Chevy Chase—Section 4, ~~pursuant to the provisions of Section 5 of Article 11E of the Constitution of Maryland.~~

SECTION 1. *Be it enacted by the General Assembly of Maryland, That Section 119-5a of the Montgomery County Code (1950 Edition), being Article 16 of the Code of Public Local Laws of Maryland, title "Montgomery County", sub-title "Chevy Chase—Section 4", be and it is hereby repealed and re-enacted, with amendments, to read as follows:*

119-5.

a. The County Council is hereby authorized, empowered and directed to levy and cause to be collected from the owners of real property in Chevy Chase—Section 4 at the time of the county levy beginning July 1, 1950 and for each tax year thereafter, a tax on the assessed valuation of the real property within said described area in
