- (2) This section shall not invalidate any license in any class which exceeds the maximum number of said class at the time of effective date of this provision, but when any such licenses in excess of the number provided hereby shall expire by virtue of revocation, cessation of business or not be renewed, then no new license shall be issued to replace it.
- (3) This section shall not apply to licenses issued under the provisions of Section 19 (g) (2), OR Section 24 of this Article.
- (4) IN PRINCE GEORGE'S COUNTY NO LICENSE SHALL BE GRANTED TO SELL ALCOHOLIC BEVERAGES IN ANY BUILDING LOCATED WITHIN ONE THOUSAND FEET OF A CHURCH OR SCHOOL BUILDING, PROVIDED THAT THIS RE-STRICTION SHALL NOT APPLY IN THE CASE OF A CHURCH, AS TO ANY CLASS A OFF SALE LICENSE OR TO ANY LI-CENSE TO SELL BEER, OR BEER AND WINE, IF THE GOV-ERNING BODY OF THE CHURCH CONCERNED SHALL CON-SENT IN WRITING TO THE GRANTING OF SUCH LICENSE, WHICH CONSENT SHALL BE FILED WITH THE APPLICA-TION, BUT THE LICENSE OF ANY PERSON OR PERSONS NOW HOLDING A LICENSE FOR ANY BUILDING LOCATED WITHIN SUCH DISTANCE FROM A CHURCH OR SCHOOL BUILDING MAY BE RENEWED OR EXTENDED FOR THE SAME BUILDING. THIS SECTION SHALL NOT APPLY TO ANY TRANSFER OR ASSIGNMENT OF A LICENSE NOW LO-CATED WITHIN THE AFORESAID DISTANCE OF ONE THOU-SAND FEET TO ANOTHER PLACE OF BUSINESS WITHIN THE AFORESAID DISTANCE AND/OR TO AN ASSIGNEE OF SAID LICENSE WITHIN SAID DISTANCE, NOR SHALL THIS SECTION APPLY TO THE ISSUANCE OF A LICENSE FOR A PLACE OF BUSINESS, NOT HAVING AN ALCOHOLIC BEV-ERAGE LICENSE, TO WHICH AN ALCOHOLIC BEVERAGE LICENSE HAD BEEN ISSUED AND WAS IN FORCE AND EFFECT ON APRIL 30, 1955, AS TO A LICENSE OF THE SAME CLASS WHICH WAS IN FORCE AND EFFECT AS OF SAID DATE, APPLIED FOR IN SAID PLACE OF BUSINESS.
