

MONTHS IN THE TAXPAYER'S FISCAL YEAR OR PERIOD WHICH FALL IN THE CALENDAR YEAR 1955 BEARS TO THE WHOLE NUMBER OF MONTHS OF SUCH FISCAL YEAR OR PERIOD. THIS SUB-SECTION SHALL BE INAPPLICABLE FOR THE CALCULATION OF ANY TAX ON ANY RETURN FILED WHICH COVERS A FISCAL YEAR OR PERIOD ENDING AFTER DECEMBER 31, 1955.

SEC. 7. 8. *AND BE IT FURTHER ENACTED*, THAT IN THE DISTRIBUTION OF INCOME TAX MONIES TO THE SEVERAL POLITICAL SUBDIVISIONS OF THIS STATE, PURSUANT TO THE PROVISIONS OF SECTION 319 OF ARTICLE 81 OF THE ANNOTATED CODE OF MARYLAND (1954 EDITION), AS AMENDED, FOR INCOME TAXES PAID TO THE COMPTROLLER DURING THE FISCAL YEAR ENDING ON JUNE 30, 1956, THE TOTAL TO BE DISTRIBUTED SHALL NOT BE IN EXCESS OF \$10,150,000.00, AND ANY EXCESS SUM WHICH WOULD HAVE BEEN DISTRIBUTED TO THE SEVERAL POLITICAL SUB-DIVISIONS PURSUANT TO THE PROVISIONS OF SAID SECTION 319, SHALL BE TRANSFERRED BY THE COMPTROLLER INTO THE GENERAL FUNDS OF THE STATE FOR THE FISCAL YEAR ENDING JUNE 30, 1956. IF THE TOTAL AMOUNT TO BE DISTRIBUTED TO THE SEVERAL POLITICAL SUB-DIVISIONS DURING THE FISCAL YEAR ENDING JUNE 30, 1956, IS NOT IN EXCESS OF THE SUM OF \$10,150,000.00, THE DISTRIBUTION SHALL BE MADE PURSUANT TO THE FORMULA CONTAINED IN SAID SECTION 319. IF THE TOTAL AMOUNT TO BE DISTRIBUTED DURING THE FISCAL YEAR ENDING JUNE 30, 1956, IS IN EXCESS OF THE SUM OF \$10,150,000.00, EACH ELIGIBLE SUB-DIVISION SHALL RECEIVE A PROPORTION OF THE SUM OF \$10,150,000.00 WHICH IS EQUAL TO THE PROPORTION OF THE TOTAL INCOME TAX DISTRIBUTION RECEIVED BY IT FOR INCOME TAXES PAID TO THE COMPTROLLER DURING THE FISCAL YEAR ENDING JUNE 30, 1955.

SEC. 9. *AND BE IT FURTHER ENACTED*, THAT IN ADDITION TO AND NOT IN SUBSTITUTION OF THE PROVISIONS CONTAINED HEREINABOVE IN SECTION 8 CONCERNING DISTRIBUTION OF INCOME TAX MONIES TO THE SEVERAL POLITICAL SUB-DIVISIONS OF THIS STATE, THERE MAY BE AN ADDITIONAL AND SUPPLEMENTAL DISTRIBUTION OF SUCH MONIES UNDER THE PROVISIONS OF THIS SECTION. IN ADDITION TO THE DISTRIBUTION OF THE SUM OF \$10,150,000.00 AS PROVIDED FOR IN SECTION 8 HEREINABOVE, THERE MAY BE A SUPPLEMENTAL DISTRIBUTION DURING THE FISCAL YEAR ENDING ON JUNE 30, 1956, IN AN AMOUNT OF \$4,336,360.00 OR ANY PORTION THEREOF IF UNDER THE PROVISIONS OF SAID SECTION 319 OF ARTICLE 81 OF THE ANNOTATED CODE OF MARYLAND (1954 SUPPLEMENT, AS AMENDED) THERE WOULD HAVE BEEN AVAILABLE FOR DISTRIBUTION SUCH SUM OR PORTION THEREOF. SUCH SUM OF \$4,336,360.00 OR ANY PORTION THEREOF SHALL BE DISTRIBUTED TO THE SEVERAL COUNTIES OF THIS STATE AND TO THE MAYOR AND CITY COUNCIL OF BALTIMORE UNDER THE PROVISIONS OF
