

2-CC (1). THE MONTGOMERY COUNTY COUNCIL IS AUTHORIZED AND DIRECTED TO FIX THE AMOUNT OF THE ADMINISTRATIVE TAX AUTHORIZED BY SECTION 2-CC ON OR BEFORE THE 20TH DAY OF THE MONTH IMMEDIATELY PRIOR TO THE MONTH IN WHICH THE COMMISSION'S FISCAL YEAR BEGINS. ON OR BEFORE THE 5TH DAY OF SAID MONTH PRIOR TO THE BEGINNING OF THE COMMISSION'S FISCAL YEAR, THE COMMISSION SHALL SUBMIT TO THE SAID COUNTY COUNCIL ITS COMPLETE BUDGET ESTIMATES FOR THE FORTHCOMING FISCAL YEAR ALONG WITH SUITABLE STATEMENTS IN JUSTIFICATION OF THE ADMINISTRATIVE BUDGET AND TAX RATE REQUESTED BY THE COMMISSION.

SEC. 2. *And be it further enacted*, That except as otherwise provided herein, all Acts or parts of Acts or laws and parts of laws inconsistent herewith or contrary hereto are hereby repealed to the extent of such inconsistency.

SEC. 3. *And be it further enacted*, That this Act ~~shall take effect June 1, 1955.~~ IS HEREBY DECLARED TO BE AN EMERGENCY MEASURE AND NECESSARY FOR THE IMMEDIATE PRESERVATION OF THE PUBLIC HEALTH AND SAFETY, AND HAVING BEEN PASSED BY A YEA AND NAY VOTE, SUPPORTED BY THREE-FIFTHS OF ALL THE MEMBERS ELECTED TO EACH OF THE TWO HOUSES OF THE GENERAL ASSEMBLY OF MARYLAND, THE SAME SHALL TAKE EFFECT FROM THE DATE OF ITS PASSAGE.

CHAPTER 379

(House Bill 553)

AN ACT to repeal and re-enact, with amendments, Sub-section (r) of Section 38 of Article 87 of the Annotated Code of Maryland (1951 Edition and 1954 Supplement), title "Sheriffs", sub-title "Compensation and Duties", relating to the expense allowance of the Sheriff and the compensation of Deputy Sheriffs in St. Mary's County and creating two additional Deputy Sheriffs.

SECTION 1. *Be it enacted by the General Assembly of Maryland*, That Sub-section (r) of Section 38 of Article 87 of the Annotated Code of Maryland (1951 Edition and 1954 Supplement), title "Sheriffs", sub-title "Compensation and Duties", be and it is hereby repealed and re-enacted, with amendments, to read as follows:

(r) St. Mary's County.—The sheriff of St. Mary's County shall receive an annual salary of \$3,300 and he shall be allowed in addition
