

the sum of \$1.00 for the renewal thereof each and every year thereafter on or before the first day of May; and said Board, at any time, may require, on any application for renewal, any applicant to pass another examination before issuing any renewal, or may SHALL issue any renewal without requiring any other examination, as said Board in each case, from year to year, may deem proper; but no charge shall be made for the issuing of permits or renewal of permits to apprentices., PROVIDED, HOWEVER, THAT SUCH CERTIFICATE OF COMPETENCY OR ANY RENEWAL THEREOF SHALL BE ISSUED BY THE BALTIMORE COUNTY PLUMBING BOARD TO ANY PERSON HOLDING A LICENSE FROM THE STATE BOARD OF COMMISSIONERS OF PRACTICAL PLUMBING UPON PAYMENT OF REQUISITE FEES AND WITHOUT EXAMINATION.

SEC. 2. *And be it further enacted,* That this Act shall take effect June 1, 1955.

CHAPTER 488

(House Bill 415)

AN ACT to repeal and re-enact, with amendments, Sub-section (d) of Section 14 of Article 2B of the Annotated Code of Maryland (1951 Edition and 1954 Supplement), and to add new Sub-sections (cc) to Sections 13, 19, 20 and 21, respectively, of Article 2B of the Annotated Code of Maryland (1951 Edition and 1954 Supplement), title "Alcoholic Beverages", sub-titles "Beer and Light Wine Licenses" and "Beer, Wine and Liquor Licenses", said new sub-sections to follow immediately after Sub-sections (c) thereof and to add Sub-section (dd) to Section 18 of said Article and sub-titles, said new sub-section to follow immediately after Sub-section (d) thereof, increasing the fees of certain alcoholic beverage licenses in Baltimore County.

SECTION 1. *Be it enacted by the General Assembly of Maryland,* That Sub-section (d) of Section 14 of Article 2B of the Annotated Code of Maryland (1951 Edition and 1954 Supplement), be and it is hereby repealed and re-enacted, with amendments, and that new Sub-sections (cc) be and they are hereby added to Sections 13, 19, 20 and 21, respectively, of Article 2B of the Annotated Code of Maryland (1951 Edition and 1954 Supplement), title "Alcoholic Beverages", sub-titles "Beer and Light Wine Licenses" and "Beer, Wine and Liquor Licenses", said new sub-sections to follow immediately after Sub-section (c) thereof and that Sub-section (dd) be and it is hereby added to Section 18 of said Article and sub-titles, said new
