

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, THAT SECTION 107C BE AND IT IS HEREBY ADDED TO ARTICLE 1 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND (1930 EDITION), TITLE "ALLEGANY COUNTY", SUB-TITLE "COUNTY COMMISSIONERS", TO FOLLOW IMMEDIATELY AFTER SECTION 107B THEREOF, AS AMENDED BY CHAPTER 267 OF THE ACTS OF 1949, AND TO READ AS FOLLOWS:

~~113. (Benefits to Teachers Retired Under Provisions of Chapter 447 of the Acts of 1920.) All pensions to teachers retired under~~

~~Chapter 447 of the Acts of 1920 in force on the date this retirement system is established shall be continued and paid thereafter from the Pension Accumulation Fund created by this sub-title; in Allegany County, any person who has taught in any of the public or normal schools thereof for twenty years and who fulfills the other requirements of said Chapter 447 of 1920, shall be paid pensions from the Pension Accumulation Fund created by this sub-title. The residue of any appropriation made for the payment of the pension of teachers retired under Chapter 447 of the Acts of 1920 shall be transferred and credited to the Pension Accumulation Fund created by this sub-title.~~

107C. THE BOARD OF COUNTY COMMISSIONERS OF ALLEGANY COUNTY IS HEREBY AUTHORIZED AND EMPOWERED IN ITS DISCRETION TO PAY A PENSION IN THE AMOUNT OF FOUR HUNDRED DOLLARS (\$400.00) ANNUALLY, TO BE PAYABLE IN MONTHLY INSTALLMENTS, TO ANY PERSON WHO HAS TAUGHT IN ANY OF THE PUBLIC OR NORMAL SCHOOLS OF ALLEGANY COUNTY FOR TWENTY YEARS OR MORE, WHO FULFILLS THE OTHER REQUIREMENTS OF CHAPTER 447 OF THE ACTS OF 1920.

SEC. 2. *And be it further enacted*, That this Act shall take effect July JUNE 1, 1955.

CHAPTER 534

(House Bill 777)

AN ACT to repeal and re-enact, with amendments, Section 572 of the Code of Public Local Laws of Anne Arundel County (1947 Edition), being Article 2 of the Code of Public Local Laws of Maryland (1930 Edition), title "Anne Arundel County," sub-title "Trailers," authorizing the County Commissioners of Anne Arundel County to prohibit, license and regulate trailer camps. IN SAID
