AN ACT TO ADD PARAGRAPH 9 TO SUBSECTION (N) OF SECTION 19 OF ARTICLE 95A OF THE ANNOTATED CODE OF MARYLAND (1951 EDITION AND 1955 SUPPLEMENT), TITLE "EMPLOYMENT COMPENSATION", SUB-TITLE "DEFINITIONS", TO FOLLOW IMMEDIATELY AFTER PARAGRAPH 8 THEREOF, PROVIDING THAT VACATION PAY UNDER CERTAIN CONDITIONS SHALL NOT BE CONSIDERED AS "WAGES" IN THE ADMINISTRATION OF THE UNEMPLOYMENT COMPENSATION LAW.

SECTION 1. Be it enacted by the General Assembly of Maryland, That Sub-section (1) of Section 19 of Article 95A of the Annotated Code of Maryland (1951 Edition), be and it is hereby repealed and re-enacted, with amendments, and that Paragraph 9 be and it is hereby added to Sub-section (n) of Section 19 of Article 95A of the Annotated Code of Maryland (1955 Supplement), title "Unemployment Compensation", sub title "Definitions", said new Paragraph 9 to follow immediately after Paragraph 8 of Sub section (n) of Section 19 thereof, and all to read as follows: THAT PARAGRÁPH 9 BE AND IT IS HEREBY ADDED TO SUBSECTION (N) OF SECTION 19 OF ARTICLE 95A OF THE ANNOTATED CODE OF MARYLAND (1951 EDITION AND 1955 "UNEMPLOYMENT COMPENSA-SUPPLEMENT), TITLE "UNEMPLOYMENT COMPENSA-TION", SUB-TITLE "DEFINITIONS", TO FOLLOW IMME-TITLE DIATELY AFTER PARAGRAPH 8 THEREOF, AND TO READ AS FOLLOWS:

- 19. (1) "Unemployment." An individual shall be deemed "unemployed" in any week during which he performs no services and with respect to which no wages are payable to him or in any week of less than full time work if the wages payable to him with respect to such week are less than his weekly benefit amount. Provided, that for the purposes of this sub-section, vacation pay, paid or payable at time of layoff or discharge where no vacation is requested by the individual, shall not be deemed payable with respect to any period following the date of the layoff or discharge.

 (9) Vacation pay, paid or payable at time of layoff or discharge where no vacation is requested by the individual.
- (9) VACATION PAY EARNED OR ACCUMULATED TO THE CREDIT OF THE INDIVIDUAL, PAID OR PAYABLE AT THE TIME OF LAYOFF OR SEPARATION FROM EMPLOYMENT.
- SEC. 2. And be it further enacted, That this Act shall take effect June 1, 1956.
