FIRST READING OF SENATE BILLS

Senate Bill No. 1—By the President:

A Bill entitled "An Act to add a new Article to the Annotated Code of Maryland (1951 Edition), to be numbered 62B, title 'Maryland Port Authority', to follow immediately after Article 62A, creating a body politic and corporate and an instrumentality of the State of Maryland to be known as the 'Maryland Port Authority' and defining its members and its powers and duties; providing for the acquisition by the Authority of certain existing port facilities of the Mayor and City Council of Baltimore, for the construction of port facilities, and for the maintenance, re-
