But it shall not be inferred from anything herein contained that it is not competent for the Judge of the proper Judicial Circuit to appoint in every such cause, where the parties forbear to exercise the power of appointment, a special Judge to sit therein having all the powers of the respective Court where such cause is pending, to bind and conclude all parties thereto by his proceedings and decision; for it is hereby expressly declared, to remove all doubt upon the subject, that every person appointed to sit as special Judge in any such cause by the Judge authorised to make the appointment, is by virtue thereof vested with all the powers aforesaid.

SEC. 4.
