Be it enacted by the General Assembly of Maryland, That whenever the Judge of the Circuit Court for the city of Baltimore shall be disqualified to sit in any cause depending in said Court by reason of the happening of any of the contingencies mentioned in the twenty-second section of the fourth article of the Constitution, or in the first section of the act to provide for carrying into effect the twenty-second section of the fourth article of the Constitution, passed at January session, eighteen hundred and fifty-two, chapter sixty-eight, the said Judge shall immediately. with the consent of the parties, after the announcment of such contingency, order and direct the bill, exhibits, answers and all other proceedings in such cause to be transmitted to the Superior Court of Baltimore city as a Court of Equity. which said Court shall proceed in, hear and determine the same, in like manner as if the said cause had been originally instituted therein.
