3. And be it enacted. That the trustees of the Roman Catholic Church in the town of Baltimore, now in office, be and they are hereby declared to be the Trustees of the Catholic Cathedral Church of Baltimore, until the next annual election shall take place, in manner and form as the pastors and trustees shall order and direct.

Rights, privileges

4. And be it enacted, That all the rights, privileges and immunities, and all the property real, personal or mixed, now held, enjoyed and possessed by the Trustees of the Roman Catholic Congregation in the Town of Baltimore, be and they are hereby declared to be, vested in the Trustees of the Catholic Cathedral Church of Baltimore.

Parts of original act repealed

5. And be it enacted, That all such parts of the original act to which this is a supplement, as are repugnant to the provisions of this act, be, and the same is declared to be hereby repealed.

CHAP. LXXXV.

Passed Jan 30 1821 An Act to repeal all that part of the Constitution and Form of Government as relates to the division of Washington County into five separate Election Districts, and for other purposes.
