Be it enacted by the General Assembly of Maryland, That upon the application of said Anthony Ricketts, executor of Sarah Briscoe, it shall be lawful for the register of wills for Montgomery county, to deliver to Anthony Ricketts, of the said county, the original will of Sarah Briscoe, filed in said office, provided the said register of wills for Montgomery county shall, before the delivery of the said will of Sarah Briscoe, take an office copy of the same, and if the said will should not be recorded, duly to record the same on the records of the said office.

assed Feb 2, 1821 A Further Additional Supplement to the Act, entitled, An Act relating to Public Roads in this State and to repeal the Acts of Assembly therein mentioned.

Levy authorised pair, &c.

1. Be it enacted by the General Assembly of Maryland. That the levy courts of Charles and St. Mary's counties, or a majority of them, be and they are hereby authorised and required annually, to levy by equal assessment on the assessable property of Charles and St. Mary's counties, a sum not exceeding thirty-three and one third cents in the hundred dollars of assessable property in the said counties, to be collected as other county taxes, and paid to the levy court, or to their order, and shall be applied towards straightening and amending the public roads in said counties; and the said levy court, or a majority of them, have full power and authority to appropriate the funds arising from said tax to the said purposes, and shall apportion the same in equal proportions among all the public roads of said counties, regarding the situation and quantity of labour necessary for the improvement of such roads, and to auticipate the collection of the said taxes by permitting, (if expedient.) the supervisor or supervisors to accept of labour in lieu thereof, at the customary rate of labour for the time, which supervisor or supervisors shall issue orders to those by whom such labour may be rendered, expressing therein, THE PHYSICS SEE MADE SHIP SHIP
