

Dec Ses 1821. agreeing, they are authorised to choose a third person, whose determination shall be final and conclusive: For all lumber used by cabinet makers, to two disinterested persons, one to be a cabinet maker, the other to be a lumber measurer, one of whom to be chosen by each party, and in case they should not agree, they are authorised to choose a third person, whose decision shall be final and conclusive: For all lumber used by chair makers and for any other purpose whatsoever not above named, the same course of appeal shall be had, as is above pointed out, which shall be binding on the parties as if it was here described at full length; and in no case shall the measurer complained of be one composing the board of appeal.

Additional inspectors.

3. AND BE IT ENACTED, That the governor and council shall hereafter, in each and every year, appoint two additional inspectors and measurers of lumber for the city and county of Baltimore, who shall be appointed in the same manner, and be under the same regulations in all respects. that the eight are who are appointed by the authority of the act to which this is an additional supplement, or may be under this law, any thing contained in the act to which this is a supplement, to the contrary notwithstanding.

CHAPTER 101.

Passed Jan. 29, 1822.

An additional supplement to the act entitled, An act authorising the appointing inspectors and wood-corders, and to regulate the cording of fire-wood brought by water to the city of Baltimore for sale.

Four additional inspectors to be appointed.

BE IT ENACTED *By the General Assembly of Maryland,* That from and after the passage of this act, the governor, by and with the advice and consent of the council, shall appoint four additional inspectors and corders of the fire-wood brought by water to the city of Baltimore for sale; and the same additional inspectors and corders aforesaid shall be subject to all the provisions of the act to which this is an additional supplement.

CHAPTER 102.

Passed Jan. 30, 1822.
Preamble.

An act to lay out and make public a road in Baltimore county.

WHEREAS, It is represented to this general assembly, by the petition of sundry inhabitants of Baltimore county, that they labor under great inconvenience for want of a public road from the Town of Hamstead, to Brown's Meeting-House, and for other convenient purposes—Therefore,

Commissioners—to lay out—to be a public road.

SEC. 1. BE IT ENACTED *By the General Assembly of Maryland,* That William Houck, Jacob Boughman and Richard Hooker, be, and they are hereby appointed commissioners, and they or a majority of them are hereby authorised to lay out and open a road not exceeding thirty feet in width, at the expense of the petitioners, beginning for the same at the corner of a lot of ground belonging to William Houck, situate on the Baltimore and Hanover Turnpike Road, near the twenty-sixth mile stone on said road in said county, and runing thence through the lands of Arthur Richards and William Houck, until it intersects the old road leading to Henry Ebaugh's Mill, and thence through the lands of Jacob Miller, Jacob Myers and George Ebaugh, until it intersects the road leading from Richard Richards' mill to Nicholas Brown's mill, upon the most eligible ground, and with as little inconvenience to the landholders through whose land it may pass, as possible; and the said
