And be it enacted, That as well in the choice of a president and Votes. directors, from time to time, as in all other cases, each stockholder shall be entitled to one vote, only to be given in such manner as the president and directors shall prescribe; Provided nevertheless, that Proviso. none shall be stockholders but bonafide citizens of the United States;

6. And be it enacted, That the president and directors shall have Powers. power to rent, lease or purchase such ground and suitable houses within or adjacent to the city of Baltimore, for the erection of works, a depot or warerooms, for the reception and sale of fabrics, transacting the business of the company, and generally for the full accomplishment of their objects, as they shall from time to time deem necessary and proper.

7. And be it enacted, That at least once a year dividends of pro- Dividends. fits on the stock of the said company shall be declared and paid to the stockholders, their attorney or legal representatives at stated periods.

And be it enacted, That in order the more effectually to call the Meetings. attention of the president and directors to the interests of the company, stated meetings shall be held monthly at least, and special ones on all occasions when it shall be deemed advisable by the president; and at every such meeting the names of the attending members and minutes of the proceedings shall be recorded in a book to be provided

and kept for the purpose.

9. And be it enacted, That the original subscribers in the company, and their assignees, transferees and legal representatives, forever, transfers, &c. shall be taken and considered to all intents and purposes, as members of this company, and shall be entitled to and receive all the rights, benefits and advantages, arising from the same, by all ways and means whatever in proportion to the amount of stock paid in, or held by them respectively; Provided always, that no transfer shall be Proviso, made or deemed valid, unless it be to a bona fide citizen of the United States, residing in the state of Maryland, and entered in the books of the company, in such manner as the president and directors shall prescribe.
