WHEREAS, it has been represented to this general assembly of by the petition of Stephen Bryan, a free man of colour, that he has been committed to the gaol of St. Mary's county, by virtue of a warrant from one of the justices of the peace for the saidle county, issued at the request of a free woman of colour, charging the petitioner of being the father of an illegitimate child; and whereas it appears that the petitioner has been confined in the said gaol since February last, for want of that security required by law, which by his indigent circumstances he has no hopes of obtaining; and whereas it appears that he made application to the county court, at the two last terms for a discharge, which was refused him, on the ground of being without their jurisdiction; therefore,
