An act for the relief of Eleanor Banks, of the city of Baltimore. Section 1. Be it enacted by the General Assembly of Maryland, That Divorce. Eleanor Banks, of the city of Baltimore, be, and she is hereby divorced from bed, board, and mutual cohabitation with her husband

Thomas Banks.

2. And be it enacted, That all the right and title which the said Thomas Banks, by virtue of his marriage with said Eleanor Banks, nulled. had acquired to any property which she is or may become entitled to, in any way or manner whatever, be and the same is hereby revoked and repealed; and that the said Eleanor Banks be, and she is hereby declared capable to have, hold, take, recover, sue for, and record, by compromise, suit or suits in law or equity, all such property, in as tull and ample a manner as if she were a feme sole, and had never been married; and to hold, use and enjoy the same, for her own use and benefit, and the same to dispose of according to her will and pleasure, without the molestation, interference, hindrance or consent of her said husband, in the same manner she could or might have done were she a feme sole.
