Passed Jan 26, 1814, Preamble,

An act to lay out and make public a road in Cecil county. WHEREAS sundry inhabitants of Cecil county have preferred a petition to this General Assembly, praying that a road may be opened and laid out in said county, and the prayer of the petitioners appearing reasonable; Therefore,

Commissioners - Width & direction.

Section 1. BE IT ENACTED by the General Assembly of Maryland, That George Gale, Samuel C. Hall and John Stump of said county be, and they are hereby appointed commissioners for the purposes of this act, and that they, or a majority of them are hereby authorised and required to survey and lay out a road, not exceeding thirty feet wide clear of ditches, beginning at Port Deposit, and running as nearly straight as the nature of the ground will admit of until it intersects the road from the lower ferry on Susquehannah to Battle Swap; Provided, That the said road shall not be made to pass through the buildings, yards, gardens, or orchards of any person or persons, without the consent of the owner or owners thereof.
