AND BE IT ENACTED, That before the managers herein before named, or to be appointed as aforesaid, shall proceed to act under this law, they shall execute a bond to the state of Maryland in the penal sum of one hundred thousand dollars, with condition that they will well and truly pay all prizes, that shall be drawn in any lottery which they shall propose in virtue of this act, at the expiration of sixty days after the conclusion of the drawing of such lottery, to the persons holding the tickets entitled to such trizes, if the same shall be demanded within twelve months after the conclusion of such drawing; and that they will pay over the amount raised by such lottery or lotteries, after deducting all expences and commissioners as aforesaid, to the president and managers of the Baltimore General Dispensary, which bond shall be deposited in the office of the clerk of Baltimore county, and suits may be brought and prosecuted thereon, at the instance and for the use of any person or persons interested; in the same manner as suits are brought and prosecuted on other bonds given to the state.
