An act to authorise a lottery for finishing and completing the Protestant Episcopal Church in Frederick-Town.

Section 1. BE IT ENACTED by the General Assembly of Maryland, That William M. Beall, Doctor Phi-hp Thomas, John Grahame, George Baer, John Managers shall Hanson Thomas, Doctor John Tyler, Richard Potts, give bond Thomas Shaw, William Ross and Benjamin Rutherford of Frederick county, or such of them as may undertake to act under this law, may and they are hereby authorised to propose a scheme or schemes of a lottery for raising a sum not exceeding six thousand dollars, and to sell and dispose of the tickets thereof to any person or persons whatsoever, any law to the contrary notwithstand-
