Section 1. BE IT ENACTED by the General Assembly of Maryland, That the justices of the orphans' court of Saint Mary's county, shall have full power and authority on the petition of the said William Hebb, pro-court empow-vided they shall be sausfied that it will conduce to the ered—on petibenefit of the said child, and provided that he, the said William Hebb, shall relinquish to his said child, any claim he may have in a life estate to said land, to order a sale of the said tract of land called Good Luck, upon such terms as the said justices may think proper, and to appoint a trustee for the purpose of effecting such sale.

2. AND BE IT ENACTED, That any sale which shall be made under the authority granted by the provi-sions of this act, shall be notified to, and confirmed by the justices of the orphans' court aforesaid, before the conveyance of the property shall be made, and bond in the name of the state of Maryland, with good and sufficient security, to be approved of by the said justices, shall be given by the person or persons empowered to sell the lands and premises aforesaid, under the order aforesaid, for the due execution of the trust; which bond shall be deposited with the register of wills for Saint Mary's county, to be by him recorded among the pro-ceedings of the orphans' court of said county, and shall be subject to be put in suit by any person or persons interested therein.

3. AND BE IT ENACTED, That the trustee to be appointed by the order of the justices aforesaid, shall vested. invest the proceeds in the name of the said infant, in such funds as the said court shall direct.
