CHAPTER 171.

A supplement to an act entitled, an act to authorise a lottery or lotteries to raise a sum of money to make a turnpike road from Frederick-Town to Harper's Ferry and for other purposes, passed at November session eighteen hundred and twelve.

Section 1. BE IT ENACTED by the General Assembly of Maryland, That it shall and may be lawful for the president and managers of the Baltimore and Frederick-Town turnpike road company, or for a committee of managers to be appointed by them, or for a majority of the persons so appointed, to exercise all the powers vested by the act to which this is a supplement, in the commissioners therein named in the same manner and for the same purposes as directed by the said original act; *Provided*, That the persons so acting shall first comply with the provisions of the second section of the said act.

2. AND BE IT ENACTED, That it shall and may be lawful for the president and managers of the said company to commence the making of the road contemplated to be made by the act to which this is a supplement, as soon as they may deem it to be expedient.

CHAPTER 172.

An act entitled, a further supplement to an act entitled, an act to regulate and discipline the militia of this state.

Section 1. BE IT ENACTED by the General Assembly of Maryland, That whenever any regiment, squadron or troop of cavalry shall be called into actual service that the governor and council be, and they are hereby authorised and directed to ascertain and declare whether the whole or what portion thereof shall act and be armed and equipped as mounted infantry, and when the same shall be so ascertained and declared, to furnish each member thereof with a musket, carbine or rifle and the necessary equipments.

2. AND BE IT ENACTED, That whenever any troop of cavalry or company of artillery shall volunteer their services as mounted infantry or flying artillery the governor and council at their discretion are hereby authorised and empowered to accept their services as such, and to furnish each member of such troop with a musket carbine or rifle, and each company of artillery with a suitable piece or pieces of artillery and the necessary equipments.

3. AND BE IT ENACTED, That the officers, non-commissioned officers and privates of the mounted infantry and flying artillery shall in all respects be subject to the same rules, regulations and discipline as the cavalry and artillery respectively now are subject to.
