very only ; *Provided* it shall not be lawful for said Bank to issue notes of less denomination than five dollars.

20. The treasurer of the Western Shore, for the time being, shall be furnished once every year, or oftener if required, with statements of the amount of the capital stock of the said corporation, and of the debts due to and from the same ; of the amount of monies deposited therein ; of the notes in circulation ; of the cash in hand, and of the profits made ; and shall have a right to inspect such general accounts in the books of the Bank, as shall relate to the said statements ; but nothing herein contained, shall be construed to imply a right of inspecting the account of any private individual with the Bank ; nor shall such general statement, and power of inspection, be used for any other purpose, but to enable him to form a just opinion of the state of the institution, relative to the public safety, and of the profits thereof, over which he is hereby appointed guardian, as far as the same relates to the state.

14. AND BE IT ENACTED, That this act shall continue in force, until the expiration of the year eighteen hundred and fifteen, and until the end of the next session thereafter.

CHAPTER 34.

An act for altering the time of the meeting of the Commissioners of the Tax in Frederick county

Alteration.

Section 1. BE IT ENACTED by the General Assembly of Maryland, That the meeting of the Commissioners of the Tax, in Frederick county, shall be hereafter held on the first Monday in February, in each year, instead of the first Monday of April, as fixed by the forty-third section of the act entitled, "An act for the valuation of real and personal property in this state," passed at November session, eighteen hundred and twelve.

CHAPTER 35.

An act for the relief of William Wheeler, junior.

Empowered
to bring his
slaves into the
state.

Section 1. BE IT ENACTED by the General Assembly of Maryland, That William Wheeler, junior, be, and he is hereby authorised and empowered to remove, import, and bring into this state, at any time within one year after the passage of this act, such slave or slaves, as have been given, or may be given to him by his father in law, Lewis Blackburn, of the state of Virginia, and which slave or slaves, or the mothers of which slave or slaves, shall have been resident of the state of Virginia, three whole years next preceding such removal or importation, and the same to retain as slaves.

2. AND BE IT ENACTED, That nothing herein contained, shall be construed to enable the said William Wheeler, junior, to sell or dispose of any slave or slaves, imported by virtue of this act, or their increase, until the said slave or slaves shall have resided within this state,
