and convey to the purchaser or purchasers the aforesaid premises, and that the proceeds of the sale aforesaid when collected by the said trustee shall under the direction of the orphans court of Allegany county be invested in such manner as said court shall direct.

4. AND BE IT ENACTED, That the said trustee before she proceeds to act under the provisions of this act, give bond with such security as shall be approved of by the judges of the orphans court aforesaid, conditioned for the faithful performance of the trust reposed in her by this act with such penalty as the said court shall direct.

CHAPTER 55.

An act to incorporate the Patapsco Insurance Company.

WHEREAS, sundry persons within this state have formed themselves into a society for the insurance of ships and merchandize, and lending money on bottomry and respondentia, and have prayed to be incorporated by law: *Therefore,*
