BEIT ENACTED By the General Assembly of Maryland, That all the estate, right, title and interest of the state of Maryland, of, in and to the tract of land called M'Leans' Recovery, situated in Baltimore county, for which a patent was issued in the name of Henry Harford, to Azariah M'Lean, bearing date on the twenty seventh day of November, in the year seventeen hundred and seventy six, which land is described by courses and distances in the said patent, and is said to contain sixty five acres of land, more or less, be and the same is hereby relinquished unto and vested in George Grundy of the city of Baltimore, to hold the same to him, his heirs and assigns for ever, in as ample and benificial manner, as if the said patent had been regularly and rightfully issued.
