An act for the benefit of the widow and heirs of William 16, 1815.

WHEREAS it has been represented to this general Pleamble. assembly by the petition of Catherine Holland, widow of William Holland, deceased, that the said William died intestate, possessed of some real and personal property, leaving nine children all minors. And whereas it is represented that the interest of the said minors would be greatly promoted by the sale of a part of the real estate

for the creditors; Therefore,
SEC. 1. BE IT ENACTED by the General Assembly of Maryland, That the orphans' court of Montgo- may order a mery county shall have full power and authority, on the sale-trustee's petition of the said Catharine Holland, (Provided, the bond. court shall be satisfied that it will conduce to the interest of the said monies) to order the sale of any part of the said real estate upon such terms and upon such conditions as the court may think proper, and to appoint a trustee for the purpose of effecting such sale, which said trustee before he proceeds to act by virtue of this appointment, shall give bond to the state of Maryland in such penalty, and with such security as shall be prescribed and approved of by the said court for the faithful performance of the trust reposed in him.

2. AND BE IT ENACTED, That the said bond, shall be filed, and recorded in the office of the register of wills of Montgomery county, a copy whereof under the seal of the orphans' court of the said county shall be received in evidence in any court of law or equity in this
