CHAPTER 79.

An act for the benefit of persons who have emigrated into this state since the adoption of the constitution of the

United States. SEC. 1. BE IT ENACTED by the General Assembly of Maryland, That in all cases where any alien hath land, emigrated into this state since the adoption of the con-stitution of the United States and hath acquired or be-come entitled to lands and tenements therein, if such person after such acquisition as aforesaid, hath been naturalized according to the laws of the United States then... and in such case he or she shall quietly have, possess and enjoy such lands and tenements in the same manner. as he or she might or could have done if he or she had been a naturalized citizen at the time of such acquisition; Provided nevertheless, that nothing herein contained Provisor shall be construed to interfere with or affect the rights br interest of any other person or persons acquired before. the passage of this act.

CHAPTER SO.

An act relating to the poor of Caroline county.
