CHAPTER 112.

An act for the benefit of Henny Hicks of Anne-Arundel

Sec. 1. BE IT ENACTED By the General Assembly of Maryland, That all the right, title, interest and claim which the linquished. State of Maryland hath or may have in and to a house and lot in the city of Annapolis, being part of lot number sixty seven, late the property of John Hicks, (a free man of colour) deceased, be and the same is hereby released and relinquished to Henny Hicks (a free woman of colour,) and her heirs.

2. AND BE IT ENACTED, That the executors of Robert Peter deceased, or other person or persons legally authorised to convey the estate, be and they are hereby authorised and empowered to convey and transfer in fee simple to the said Henny Hicks and her heirs, all the right, title, interest and estate by the said executors sold or contracted to be sold to John Hicks deceased, of in and to the above mentioned house and lot in case the purchase money hath been or shall be paid therefor; Provided nevertheless, that the said house or lot shall be liable for and subject to the payment of the debts if any due and owing by the said John Hicks, in case of the insufficiency of the personal estate left by him.
