Proviso.

An act to authorise the president and directors of the Choptank Bridge Company to contract with the Levy Court of Caroline County for the passage of the citizens of said county over the said bridge, and for other purposes.

WHEREAS, It is represented to this General Assembly, by the petition of sundry inhabitants of Caroline county, that Dover Causeway is kept up for the use and benefit of the Choptank Bridge Company, at an enormous expence to the citizens of said county; Therefore,

Sec. 1. BE IT ENACTED by the General Assembly of Maryland, That it shall and may be lawful for the president and directors of the Choptank Bridge Company to contract with the levy court of Caroline county, for the passage of the citizens of said county over said bridge, for a sum of money not exceeding three hundred dollars annually, to be levied on the assessable property of said county, and collected as other county charges, and paid over by the collector of said county, to the president and directors as aforesaid, or to any person authorised by them to receive the same.

2. AND BE IT ENACTED, That in case the president and directors as aforesaid shall refuse or neglect to contract with the said levy court at their first meeting after the passage of this law, or at their first meeting in any year thereafter, then and in that case so much of the public road leading from Huarig Creek to the said Choptank Bridge, commonly called and known by the name of Dover Causeway, shall be vacated and discontinued, and not considered as a part of a public road in Caroline county; *Provided nevertheless*, that the said president and directors on refusing or neglecting to contract with the levy court of Caroline county as aforesaid, shall have full power, and they are hereby authorised to repair and keep up the said causeway as a public highway at the expence of the said company, any law or usage to the contrary notwithstanding.
