CHAPTER 126.

A supplement to the act entitled, an act to authorise and empower the Levy Court of Charles County to assess and levy

Sec. 1. BE IT ENACTED by the General Assembly of Maryland, That the commissioners appointed by the act to

which this is a supplement, or a majority of them, shall be and they are hereby authorised and required to collect immediately all such sum or sums of money as are or were raised or levied under the provisions of the aforesaid act, and such sum or sums when so collected shall be applied to the building of a court house, which shall be erected on the public ground in Charles Town, commonly called Port Tobacco, in Charles county, and when erected, finished and completed shall be used, held, taken and deemed to be the proper court house of Charles,

2. AND BE IT ENACTED, That the said commissioners are hereby empowered and directed to proceed as soon as practicable, in the accomplishment of this work, and they are hereby vested with all powers necessary for this purpose.
