BEIT ENACTED by the General Assembly of Maryland, That the levy court of Harford county shall levy such sum of money as they in their judgment shall deem necessary, not exceeding three hundred dollars, for erecting a bridge over a washed gutter, occasioned by the overflowing of Deer Creek, at Robert Gover's mills, on the road leading from St. George's chappel to Havre De-Grace.

2 AND BE IT ENACTED, That Joshua Husband is hereby appointed to superintend the erection of said bridge, Superintenand required to do the same or have it done at the least possible expence, that will serve the public convenience as he in his

judgment shall think proper.
