SEC. 1. BE IT ENACTED by the General Assembly of Maryland, That the vestry of St. Mark's Parish in Frederick county, or a majority of them be, and they are hereby authorised to propose a scheme of a lottery, and to sell and dispose of tickets therein for raising a sum of money not exceeding six thousand dollars, to be appropriated by them to the building

a church or house of worship in said parish.

Bond.

2. AND BE IT ENACTED, That before the said vestry proceed to make sale of any ticket or tickets in the said lottery, they shall give and execute a bond to the State of Maryland. in the penalty of twelve thousand dollars, conditioned that they will well and truly conduct the drawing of said lottery, and apply the monies arising therefrom within six months after the drawing thereof to the payment of the prizes drawn therein, to the adventurers to whom they shall be due, and the necessary expences incorred in the management thereof, and the residue to the building a church in the said parish.
