WHEREAS, it appears to this General Assembly, that James Wilkinson, an officer of the revolutionary war, and who served to its termination, did not receive the commutation money of five years pay, in lieu of half pay for life, promised to the officers and soldiers, who continued in service to the end of the war; therefore,

Resolved, That the treasurer of the Western Shore be, and he is hereby authorized and directed to pay to the said James Wilkinson, yearly in quarterly payments, during life, the half pay of a colonel of dragoons, as remuneration for services rendered his country in the revolutionary struggle for liberty.

No. 48.

Resolved, That the treasurer of the Western Shore be, and he is hereby directed to pay to Emanuel Ebbs, late a private in the revolutionary war, or to his order annually in quarterly payments, a sum of money equal to the half pay of a private, as a further remuneration to him for those services by which his country has been so essentially benefited.

No. 49.

Resolved, That the governor and council be, and they are hereby authorized and empowered to call in, in such manner and at such time or times as they in their discretion may fix on, the arms, camp equipage, &c. distributed among the militia of this state, or to take such other order with regard to the same, as they in their judgment shall think best calculated to advance the improvement of the militia always securing a safe return of the said arms, camp equipage, &c. to the state in as good order as practicable.

Resolved, That a sum not exceeding five hundred dollars out of any unappropriated money in the treasury, be, and the same is hereby placed at the disposal of the governor and council to carry into effect the above resolution.
