CHAPTER. 33.

An act for erecting a bridge over the Potomac, near Williamsport in Washington County.

WHEREAS, It is represented to this General Assembly by the inhabitants of Williamsport, and its vicinity, in Washing-

ton county, that they together with a number of other inhabi-tants, of Virginia, are desirous of forming a company for the purpose of erecting a bridge over the Potomac; There-

fore, Sec. 1. BE IT ENACTED by the General Assembly of Maryland, That Jacob T. Towson, Edward G. Williams, Samuel books sub-Ringgold, John Buchanan, Matthew Van Lear, Robert T. scriptions-Friend, Rawleigh Colston, Elisha Boyd, Archibald Shearer shares. and Thomas C. Smith be, and they are hereby appointed managers to do and perform the several duties herein after named, that is to say; they or any two of them, shall and may on or before the first day of May next, procure one or more books, as to them shall seem necessary and shall enter therein as follows: " we whose names are hereunto subscribed, promise to pay to the Potomac river, the sum of two dollars and fifty cents at the time of subscribing, and the sum of two dollars and fifty cents every sixty days thereafter, until twenty dollars be paid upon every share of stock in said company, set opposite our respective names;" and shall thereupon proceed to receive subscriptions for the stock of the said company, which is hereby declared to be the sum of forty thousand dollars, divided into two thousand shares of twenty dollars each, at such time and place as they think proper, of which three weeks notice shall be given in the two newspapers published at Hagers Town, and shall keep the said books open for the space of three weeks, unless the whole number of shares be sooner subscribed for, which subscriptions may be made by person, or by proxy; and in case the whole number of shares shall not be subscribed for in that time, the said managers, or any two of
