An act to establish a Bank, and incorporate a company to be styled the Bank of Westminster.

Sec. 1. BE IT ENACTED by the General Assembly of Maryland, That a bank to be called and known by the name of The Bank of Westminster, shall be establish in the town of Westminster, in Frederick county, and that the capital stock of the said bank shall be limitted to three hundred thousand dollars, to consist of twelve thousand shares of twenty five dollars each.
