Corporation not to hold real property, &c. 10. *And be it enacted*, That the said corporation shall not be competent to purchase or hold any real or leasehold property, other than such as may be recovered by them for premiums, and as may be necessary for their immediate accommodation in business.

General meeting of stockholders may be called, &c. 11. *And be it enacted*, That the president and directors may call a general meeting of the stockholders for any purpose relative to the affairs of the institution, giving at least two weeks notice in one or more of the newspapers printed in the cities of Baltimore and Annapolis, Frederick-Town and Hager's-Town, on the western shore, and in the paper printed at Easton on the eastern shore; and any number of stockholders, not less than forty, who together shall be proprietors of one thousand shares, may at any time apply to the president and directors to call a general meeting of the stockholders for any purpose relative to the affairs of the institution; and if the president and directors shall refuse to call such meeting, the said number of stockholders, proprietors of not less than the aforesaid number of shares, shall have power to call a general meeting of the stockholders, giving at least two weeks notice in one or more of the newspapers printed in the cities of Baltimore and Annapolis, Frederick-Town and Hager's-Town, on the western shore, and in the paper printed at Easton on the eastern shore, specifying in such notice the object or objects of such meeting.

Duration. 12. *And be it enacted*, That this act shall continue and be in force until the first day of February, eighteen hundred and twenty, and until the end of the next session of the general assembly thereafter.

CHAPTER 17.

Passed Dec. 16 An act relating to the Collection of the Public Taxes in Baltimore County.
