Be it enacted by the General Assembly of Maryland, Society incor-That Elisha De Butts, Samuel Baker, Tobias Watkins, Max-porated. well McDowell, Richard W. Hall, Ezra Gillingham, John B. Caldwell, Thomas Hall, Richard W. Hall, Nathaniel Potter, and James Middleton, and such persons as they may from time to time elect, and their successors, are hereby declared to be one community, corporation and body politic, for ever, by and under the name and title of The Medical Society of Maryland, and by and under the same name and title they shall be able and capable in law to sue or be sued, to prosecute or defend any suit in equity and law, to purchase, take, have and enjoy, to them and their successors, in fee, or for less estate or estates, any lands, tenements, rents, annuities, chattels, bank stock, registered debts, or other public securities within this state, by the gift, bargain, sale or devise, of any person or persons, bodies politic or corporate, capable to make the same, and the same at their pleasure to alien, sell, transfer or lease, and apply to such purposes as they may adjudge most conducive to the promoting medical knowledge; Provided nevertheless, that the said medical society, or body politic, shall not at one time hold or possess property real, personal or mixed, exceeding in total value the sum of five thousand dollars per annum.
