WHEREAS it is represented to this general assembly, by the Preamble. rector and vestry of Saint John's Parish, in Harford and Baltimore counties, that by the last will and testament of Jeremiah Eaton, and by an act of assembly passed in June, in the year one thousand seven hundred and nineteen, the rectors of said parish became entitled to a certain tract of land in Harford county, called Stockley Manor, or Stock Flemmen: And whereas the rector and vestry of said parish are desirous of selling said land, for the purpose of vesting the proceeds thereof in some monied institution for the benefit of the present rector, and his successors, Therefore,
