CHAPTER 260.

An act to Incorporate the Baltimore Improving Company, Passed Feb. 5.

Sec. 1. Be it enacted by the General Assembly of Maryland, corporated. That Robert Oliver, Henry Payson, William Lorman. George Williams, Peter Hoofman, Nathaniel Williams, Dennis A. Smith, Solomon Etting, Alexander M. Donald, Henry Didier, junior, James Mosher, and William Gwynn, their associates, successors and assigns, be and they are hereby created a corporation and body politic, by the name and style of The Baltimore Improving Company, and by that name shall have succession during the continuance of this incorporation, and shall be able and capable in law to sue and be sued, implead and be impleaded, answer and be answered, in any court of law or equity, and to make and use a common seal, and the same to change and alter at pleasure, and to ordain and establish such by-laws and regulations, not contrary to law, as shall be necessary or convenient for conducting the affairs of this corporation.

2. And be it enacted. That the capital stock of the said com- Capital stock; pany shall consist of five hundred shares of one thousand dollars each; and for the purpose of making public improvements within the city and precincts of Baltimore, they are hereby empowered to purchase, hold, and dispose of, personal property and real estate, in fee simple, or otherwise, and in cases of sales of property requiring to be acknowledged and recorded, a majority of the directors shall join in executing and acknowledging, accord-

ing to law, conveyances thereof. 3. And be it enacted, That there shall be a meeting of the Five directors stockholders of the said company on the first day of April in to be elected. every year, or within ten days thereafter, for the purpose of electing five directors to manage all the concerns thereof, who

shall be elected by ballot in person or by proxy; and each share shall entitle the holder to one vote.
