CHAPTER 138.

A Supplement to the act, entitled, An act authorising a Passed Jan. 28 Lottery to raise a sum of money for certain purposes therein mentioned.

Be it enacted by the General Assembly of Maryland, 100,000 dollars That the lottery or lotteries authorised by the act to which this is a supplement, shall and may be enlarged, to raise in the whole amount a sum not exceeding one hundred thousand dollars, clear of expenses, to be conducted under the provisions of said act, and the penalty of the bond required thereby shall be double the amount mentioned; and the money so raised shall be apportioned and applied, one half to the improvement of Harford street, as directed in said act, and the other half to the deepening and walling such parts of Jone's Falls as are or may be
