CHAPTER 187.

An act for the benefit of a Religious Society in Frederick Passed Feb 14

County called The United Brethren. WHEREAS, it is represented to this general assembly, by the pe- Preamble. tition of certain members of a religious society called The United Brethren, in Frederick county, that certain lands lying in said county called The Giff, containing ten acres more or less; part of a tract of land called Content, containing thirty acres more or less; a part of a tract of land called Smith's Hap, containing half an acre and twenty perches; and part of a tract of land called Content, containing three-fourths of an acre, were in the years seventeen hundred and fifty-eight, seventeen hundred and eighty-two, and seventeen hundred and eighty-eight, conveyed to certain trustees for the use and benefit of said society, and that doubts are entertained as to the title derived under said deeds; and the said petitioners having petitioned that the title of said society to said lands may be confirmed and vested for their use in certain trustees, Therefore,
